CONDITIONS OF SALE

- 1. The highest bidder shall receive the lot. Any dispute arising who is the highest bidder shall be determined by the Auctioneer, who may offer the lot again.

- 5. Postal bids must comply with the rises of the Auctioneer, i.e.

Up to \$20 in increments of \$1,

Above \$20 in increments of \$2,

Above \$50 in increments of \$5,

Above \$100 in increments of \$10

Or at the discretion of the Auctioneer

Postal bids not in accordance with these steps will be lowered accordingly

- 6. If two or more identical bids are received, those received by mail will have precedence over room bidders. The use of a "+" sign will signify that the person representing the postal bidder may bid one more rise.
- 7. No bids will be accepted below the reserve stated in the catalogue.
- 8. Lots are not available for inspection by post.
- 9. Brighton Philatelic Society acts only as the agent of the seller and is not responsible for any faults in any lot or for any errors of description or for the genuineness of any lot. Prospective buyers (with the exception of postal bidders) are strongly advised to examine personally any items in which they are interested, before the auction takes place. From the time a lot is knocked down ('sold'), and the invoice paid, such a lot will be the responsibility of the buyer.
